# ATTENDEE INFORMATION

Welcome to The Orleans and the 2019 USBC Convention. The following information will assist you in the procedures for the USBC Convention and Annual Meeting.

This year, the USBC Convention and Annual Meeting will have informative seminars, the annual Meet for the Cure and Bowlers to Veterans Link celebrations, the legislative session and USBC Board of Directors elections.

All USBC members are entitled to address the delegation during the Annual Meeting, so it is important for all attendees to have registered and received the appropriate credentials.

## WHAT YOU WILL NEED

- Laminated Identification Badge
- Convention Program. This program has schedules and information you will need during the convention. A limited number of replacement books will be available.
- Notepad and pens

Casual clothing is acceptable for seminars and the Annual Meeting. Comfortable shoes also are recommended.

## ASSOCIATION REPRESENTATIVES

Written or verbal authorization from the association manager or president is required to add a new delegate/alternate or to change an alternate to a delegate.

Association delegates who change to athlete-delegate status will be verified by the registration staff and issued a new badge.

## SEMINARS & USBC HALL OF FAME DINNER

Seminars are on a tight schedule, so please plan to arrive at least 10 minutes early.

For those who have purchased tickets, the 2019 USBC Hall of Fame ceremony is set for Wednesday, May 1, in the Esplanade at The Orleans. A reception starts at 5:30 p.m., and the dinner will start at 6:30 p.m. The dress code is business casual (no jeans, tennis shoes or shorts). A limited number of seats for the dinner might be available for purchase.

## ANNUAL MEETING SEATING

For the Annual Meeting, there will be seating for voting delegates, based on geographic region, and a section for alternates, members and guests. Only delegates with the appropriate badge may sit in the delegate section. The 2019 Annual Meeting will be held over two days, starting at 1:30 p.m. on Wednesday, May 1. The second session on Thursday, May 2, starts at 9 a.m. Attendees must be in their seats at least five minutes prior to the start each session.

## ATHLETE-DELEGATES

Athlete-delegates are represented at the highest policy-making levels. Bowlers designated as actively engaged athletes – top finishers at the 2016 Open Championships, 2016 Women's Championships and 2016 Junior Gold Championships plus Team USA members within the past 10 years – are eligible to be delegates to the USBC Convention and many have accepted the invitation to represent fellow athletes. They have the same voting privileges as association delegates.

## GUESTS/VISITORS

Family members and guests are welcome to attend the Annual Meeting. A special section is reserved for guests.

## SPECIAL ASSISTANCE

Anyone requiring special accessibility or accommodations at the Annual Meeting should come to the Registration desk so arrangements can be made.

## PROPOSED AMENDMENTS

One of the most important duties of a delegate is to vote on proposed legislation. The legislative session will take place Thursday, May 2. Please take a moment to thoroughly review the proposed amendments prior to attending the Annual Meeting. USBC encourages you to contact the Rules team in advance if you have any questions.

## BOARD ELECTIONS

Delegates will vote on three open positions on the USBC Board of Directors. 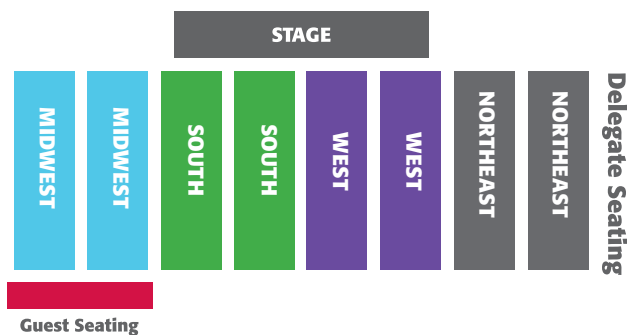

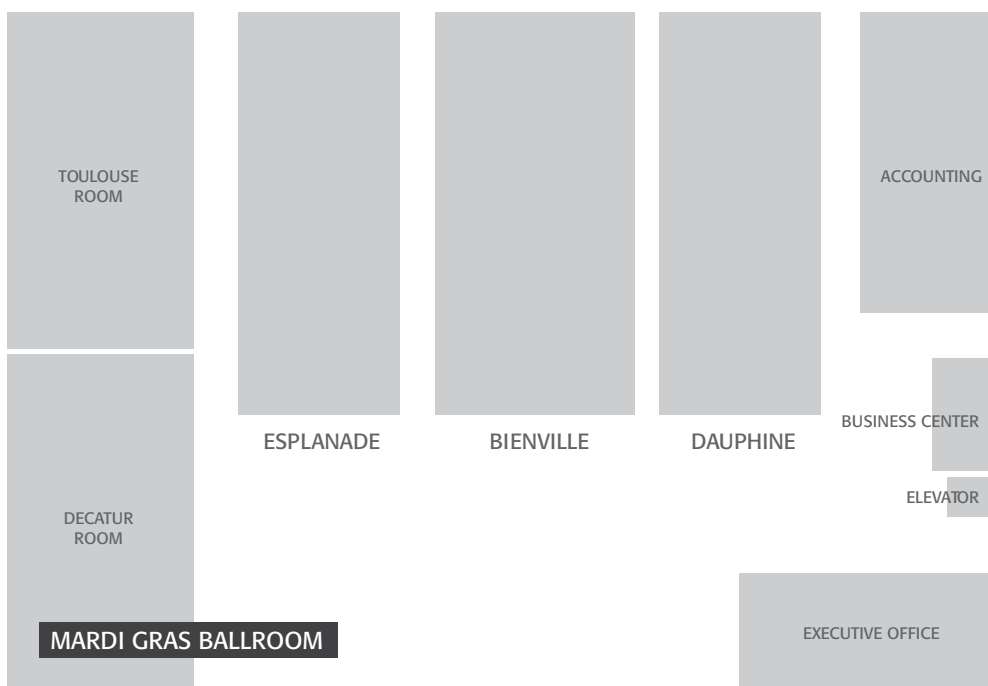

KELLY KULICK**

Kelly Kulick, 42, of Union, New Jersey, made bowling history in 2010 when she captured the Professional Bowlers Association (PBA) Tournament of Champions title to become the first woman to win a PBA Tour event.

Following an outstanding collegiate career at Morehead State, where she was a three-time National Collegiate Bowling Coaches Association (NCBCA) Most Valuable Player Award winner, Kulick captured Professional Women's Bowling Association (PWBA) Rookie of the Year honors in 2000.

She would win the first of her six major titles at the 2003 U.S. Women's Open. She claimed USBC Queens titles in 2007 and 2010, and added U.S. Women's Open titles in 2010 and 2012.

Kulick is a 14-time and current Team USA member. Her international resume includes a then-record performance in winning gold in singles at the 1999 World Bowling World Championships, the first of her 22 career gold medals in international competition. She was named an assistant coach to the Team USA program in 2017.



**2019 USBC  
HALL OF FAME  
INDUCTIONS**

The USBC Hall of Fame was created in 2005 by merging the former American Bowling Congress and Women's International Bowling Congress halls of fame. With seven inductees in 2019, the USBC Hall of Fame will have 432 members – 223 in Superior Performance, 120 in Meritorious Service, 51 in Veterans, 22 in Pioneers and 16 in Outstanding USBC Performance.



**SUPERIOR PERFORMANCE  
CHRIS BARNES**

Chris Barnes, 49, of Double Oak, Texas, owns 19 Professional Bowlers Association (PBA) Tour titles, including three majors – the 2005 U.S. Open, 2006 PBA Tournament of Champions and 2011 PBA World Championship. The 1998 PBA Rookie of the Year and the 2007-2008 PBA Player of the Year is one of five bowlers to have won both awards and one of six to have won the PBA Triple Crown.

He has made 85 career PBA Tour TV finals appearances and was in the top 10 in PBA season earnings for 16 consecutive seasons. Barnes was elected to the PBA Hall of Fame in 2018.

A 16-time member of Team USA, the most of any male bowler, Barnes captured the first two of his 22 career gold medals at the 1995 Pan American Games (doubles, team). He was named the United States Olympic Committee's Athlete of the Year for Bowling in 1994, 1996 and 1997.

At Wichita State, he earned Collegiate Bowler of the Year honors for the 1991-1992 season from the Bowling Writers Association of America



**SUPERIOR PERFORMANCE  
MIKA KOIVUNIEMI**

Mika Koivuniemi, 52, is a Finland native who lives in the United Arab Emirates, where he coaches the national team, a position he has held since 2015.

He competed overseas before joining the Professional Bowlers Association (PBA) Tour at age 32. While he would win 14 titles on the PBA Tour, his first two titles were majors – the 2000 USBC Masters, in his first PBA television appearance, and the 2001 U.S. Open – to earn the nickname Major Mika.

He captured his third major, and a \$250,000 paycheck, at the 2011 PBA Tournament of Champions. He is a two-time PBA Player of the Year (2003-2004, 2010-2011) and was inducted into the PBA Hall of Fame earlier this year.

He has won 25 medals competing for Finland in international competition, is an eight-time Finnish Bowler of the Year and was inducted into the Finnish Bowling Federation Hall of Fame in 2017.





**MERITORIOUS SERVICE  
JOHN DAVIS**

John Davis, who passed away on Jan. 25, 2013, at age 64, started Kegel in 1981 on the heels of developing The Key™ Lane Cleaning Tool, which provided bowling centers a better and more economical way to clean lanes.

With a goal of making “two lanes play the same,” he became a leading innovator and expert in the field of lane maintenance throughout a career that had a major impact in the sport. Kegel was the first independent lane maintenance company to handle the lanes for the Professional Bowlers Association (PBA) Tour and Davis also served as Chairman of the World Tenpin Bowling Association Technical Committee, where he was instrumental in changing the format to short and long oil patterns for competitions.

Davis opened the Kegel Training Center in 1997, moving it to its current location in Lake Wales, Florida, in 2003, to give bowlers and coaches the latest technological advances to take their knowledge to the next level. His last invention was the Kegel LaneMapper, which measures lane topography.



**MERITORIOUS SERVICE  
BOB JOHNSON**

Bob Johnson, 61, of Las Vegas, has been at the forefront of telling bowling’s stories for nearly five decades.

He began writing about the sport for Pacific Bowler at the age of 15 and has gone on to serve as editor of five national bowling magazines, including Bowlers Journal International and Bowling Center Management. He has been honored with 75 national writing awards for his work covering the sport and industry.

He served as an administrator for the World Bowling Writers for eight years, while also serving on several committees, and has been a USBC Hall of Fame committee member since its formation.

In 2009, Johnson was selected as the Bowling Writers Association of America (now International Bowling Media Association) Luby Hall of Fame Award winner, and he was inducted into the Professional Bowlers Association (PBA) Hall of Fame earlier this year.



**PIONEER  
LARRY LICHSTEIN**

Larry Lichstein, 69, of Fort Myers, Florida, who was elected to the Professional Bowlers Association (PBA) Hall of Fame in 1996 in the Meritorious Service category, made his mark as the long-time Director of Player Services for the PBA.

He started his PBA career as a bowler in 1969, becoming the youngest PBA Rookie of the Year at the time of his selection. He would win his lone PBA title at the San Jose Open in 1970.

In May 1974, Lichstein changed career paths, and for more than 22 years would serve as the PBA Director of Player Services where he equipped, fit, maintained and served up to 300 PBA Tour bowlers each week.

Lichstein also owns two USBC Open Championships titles, winning a title in each of his first two years competing at the event. He won the Classic All-Events title in 1969 and was a member of the 1970 Classic Team champion. He has six other top-five finishes at the tournament.



**VETERANS  
JIM ST. JOHN**

Jim St. John, who passed away Jan. 11, 1987, at age 56, served in the Navy for nine years before he turned to bowling full time. He competed on the Professional Bowlers Association (PBA) Tour from 1963-1969, capturing the first of his six titles at the 1963 Rockford Coca-Cola Open.

His most dominating performance came at the 1963 World Invitational, one of the most prestigious tournaments in bowling, that took place in Chicago. St. John set 12 tournament records, tied two others, and posted the only 300 game over the course of the 11-day tournament. He successfully defended his title at the 1964 event.

He also won a USBC Open Championships Classic Team title in 1964 and had three other top-five finishes at the tournament.

St. John was a two-time Bowlers Journal and American Bowling Congress All-American first-team member. He was elected to the PBA Hall of Fame in the Veterans category in 1989.

## HELEN BAKER AWARD FOR OUTSTANDING ASSOCIATION SERVICE

### KAY SMITH

**Bryan, Texas**

Kay Smith, who was inducted into the Texas State USBC Hall of Fame in 2012, has more than 40 years of association service. She started as a league secretary in 1973 and, a year later, she became a member of the Bryan/College Station Board of Directors and has served in various roles, including president. She was president for the first three years of the newly merged Brazos Valley USBC in 2006 and returned in 2016 to again serve in that role.

She has been the association manager for the Texas State USBC since 2010 and has extensive service on the state level for both adult and youth associations. She joined the state youth board in 1989 and has served in all capacities, including president. She helped develop the state's youth scholarship program and youth Masters and Queens events.

She has been a certified coach for more than 40 years and a certified lane inspector for more than 30 years.



## JOYCE DEITCH UNITY AWARD

### PATTY PATTERSON

**El Paso, Texas**

Patty Patterson's family started the Gibby Daniels Scholarship Foundation in 2012 in memory of her brother, who passed away in 2010 at age 53. Each year, the foundation awards scholarships to high school bowlers in the El Paso area, and, while all family members are involved, Patterson handles much of the organization of events and fundraising.

The foundation has awarded more than \$40,000 in scholarships and assisted with funding for 2018 Junior Gold Championships qualifying events.

She also is involved with the bi-national bowling associations that bring together bowlers from Texas, New Mexico and northern Mexico every three months for competition and camaraderie. The events draw more than 250 competitors.

The El Paso USBC has twice honored Patterson and her family with the Gene Calabro Bowling Ambassador of the Year award, and she was inducted into the El Paso USBC Hall of Fame in 2001.



## USBC PROPRIETOR OF THE YEAR

### JOSEPH POELKING

**Springboro, Ohio**

Joseph Poelking is the owner of three centers in the Dayton, Ohio, area – Poelking Lanes South, Poelking Woodman Lanes and Poelking Lanes. His centers are home to 33 adult leagues and 11 youth leagues that support more than 1,800 USBC members.

He was selected as the 2013 Bowling Proprietors' Association of America (BPAA) Proprietor of the Year for the state of Ohio, has served on the BPAA board, and did two separate terms as president of the BPA of Greater Dayton. He currently serves on the Strike Ten Entertainment board and has been the state president and executive board chairman of the Bowling Centers Association of Ohio (BCAO).

He was inducted into the Ohio Bowling Council Hall of Fame for meritorious service in 2017 and received the BCAA Hall of Fame Meritorious Service Medal in 2012. His centers have hosted many local and state events, including the 2019 Intercollegiate Team and Singles Championships.

## VOLUNTEER OF THE YEAR

**LENNY HIGGINS**  
Columbus, Ohio

Lenny Higgins has coached at Sequoia Pro Bowl for the last 22 years and has served as the assistant youth coordinator at the center for the last 12 years. He serves on the Central Ohio USBC Youth Advisory Council and is a member of the association's youth committee.

He developed the "On the Spot" awards for the youth leagues to provide immediate recognition for achievements on the lanes and the program soon was adopted by other area centers. He helped form teams from the Sequoia Pro Bowl leagues for the city youth championships and the center's teams claimed first in Bumper Boys, Bantam Boys, Bantam Girls and Prep Boys.

Four years ago, a local middle school sought to start an after-school bowling club and Higgins volunteered to assist getting the program underway. What started with 30 students has grown to encompass three middle schools and 80 students.

Higgins was named the Central Ohio USBC Coach of the Year in 2004 and 2013, and was selected by the Ohio State USBC Youth Association as Volunteer of the Year in 2017.

The USBC Youth Volunteer of the Year, which recognizes an adult volunteer who has displayed outstanding efforts to foster, organize and promote certified youth bowling programs at the local, state and/or national level.



## DAVID DAHMS COACH OF THE YEAR

**CONNIE EMLICH**  
Columbus, Ohio

Connie Emlich has coached in the Saturday morning youth league at Sequoia Pro Bowl for 33 years. When her daughter turned 6 and started bowling at the center, Emlich decided she also wanted to be part of the program after seeing how much her daughter enjoyed the sport.

"So now, 35 years later, I am still coaching and still enjoying it," Emlich said. "I am now coaching my own grandchildren."

Emlich organizes teams for youth tournaments and helps with the year-end banquet, which includes getting together the more than 100 prizes for the youth bowlers, and she collects money during Youth Bowler Week, a fundraiser for the Central Ohio USBC Youth program.

She also is involved with high school bowling, having coached the DeSales High School team for the last 10 years.

Emlich is a multiple award winner in Ohio, having been named Coach of the Year by Central Ohio USBC (2015) and the Ohio State USBC Youth Association (2016).

The David Dahms Coach of the Year Award is presented to a USBC-certified coach who has been actively involved in a USBC Youth program and has demonstrated an outstanding commitment to coaching, sportsmanship and knowledge of USBC Youth rules.

## Don't forget about these changes going into effect:

*This bowling season, August 1, 2019:*

- No liquid cleaners can be used during competition. Liquid cleaners are still allowed before and after bowling competition.

*Next bowling season, August 1, 2020:*

- Elimination of balance holes. Bowlers may have up to five holes for gripping purposes and all gripping holes must be used on every delivery. An unused gripping hole will be considered a balance hole, which will not be allowed.
- Increase ball static weight up to three ounces of side weight and three ounces for finger or thumb weight. Bowlers can now drill balls complying with the new static weight specifications if the ball does not have a balance hole. If the ball has a balance hole, the static weight remains at one ounce of side weight and one ounce of finger or thumb weight until Aug. 1, 2020.
- No-thumb bowlers need to mark by scribe, engraver or tool near the intended center of palm with a plus (+) mark.

After the initial request was turned down, Lee went back with more data, a faculty sponsor and evidence of student interest in the sport and received permission to start the team.

She helped organize and lead fundraising initiatives, efforts also designed to help raise awareness of the bowling team and draw more interest in the program from students.

During the 2017-2018 season, as the only girl on the co-ed team, she was selected First Team Co-ed All District for the New Orleans Region. She has excelled off the lanes, too, maintaining a 4.17 grade-point average while taking honors and Advanced Placement courses along with dual enrollment.

A senior at Kaneland High School, Mabel Cummins recently competed for Junior Team USA at the inaugural World Bowling Junior Championships in France. She teamed with Kamerin Peters to take the gold medal in doubles and won three matches in the Masters competition of the event to earn bronze.

She made her first appearance on Junior Team USA in 2018 and was a member of the gold-medal winning team at the World Bowling Youth Championships. As a member of U15 Junior Team USA in 2017, she won five gold medals and a silver medal at the Tournament of the Americas.

Cummins, who started 2019 with a runner-up finish at the U.S. Amateur Championships, won the U15 girls title at the 2016 Junior Gold Championships.

Off the lanes, she is a member of the Elite Youth Tour Board and Illinois State USBC Youth Leaders. She served as tournament coordinator for the 2016 Strike for Vets Chicago, raising nearly \$10K for Fisher House, a veterans support facility. She was selected as the USBC Youth Ambassador of the Year in 2017.

With a 4.12 grade-point average, she is in the top 10 of her class at Kaneland High School and is a National Honor Society member and Illinois State Scholar. She plans to attend Vanderbilt University, where she will compete on the women's bowling team as she works toward a degree in pathology.

# USBC ANNUAL MEETING PROCEDURES

## 1. Delegates

Delegates must register and obtain delegate badges. Delegate badges and official lanyards are required for seating in the delegate area. Only delegates seated in the delegate area will be allowed to vote. Special sections for alternates and guests are provided.

## 2. Debate

While any USBC member has the right to debate a motion, only registered delegates may make motions.

- a. Any member entitled to speak shall go to a microphone
- b. Upon recognition by the presiding officer, the member shall state his/her name and association, and will have two minutes to speak
- c. A member may not speak a second time on any motion until all members who wish to speak a first time have been recognized and will have two minutes to speak

## 3. Secondary Amendments

To assist delegates who feel any of the proposed amendments are in need of change, and to conserve time on the meeting floor, the following procedure will be followed:

- a. Any suggested changes should be submitted in writing to USBC Legal and Legislative chair or USBC staff at least 24 hours prior to the meeting

- b. The suggested changes will be studied by the USBC Legal and Legislative Committee

- c. In the event a secondary amendment to a proposed amendment is offered from the floor of the meeting which has not been considered as recommended above, it will be referred without debate to the USBC Legal and Legislative Committee. The USBC Legal and Legislative Committee will confer immediately with the proposer and report their recommendations to the delegation, except in those instances of minor changes which, in the judgment of the chair, raise no question(s)

## 4. Method of Voting

All votes shall be cast by electronic ballot, which shall be the sole method for determining votes unless the president, or in his/her absence the vice president, determines circumstances require a different method.

## 5. Parliamentary Authority

The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern the meeting in all cases to which they are applicable and in which they are not inconsistent with the USBC Bylaws and these rules.

## 6. Adoption and Suspension of Rules

- a. These rules shall be adopted by a two-thirds vote.
- b. These rules may be suspended by a two-thirds vote.

# ELECTION PROCEDURES BOARD OF DIRECTORS

USBC Board elections will take place Thursday, May 2, during the Annual Meeting.

The USBC Nominating Committee has slated four candidates for the three open positions on the board. Delegates will vote to determine the three board members who will serve three-year terms beginning Aug. 1, 2019.

Open athlete board positions are elected by athletes at a different time and are not part of this election process. The election for athlete board members is conducted according to the policies and procedures established by the Athletes Advisory Council.

## Procedures

1. The Nominating Chair will outline the election process, present the slate, announce the names and read the biographies of the nominations from the floor. The Chair's reading of the biographies of the nominations from the floor will serve as the official motion to add the names to the ballot. (See Nomination from the Floor requirements below).
2. The USBC President oversees the balloting process, calls for the vote and announces the winners or the need for additional ballots. If the president is absent or on the ballot, the duties fall to the vice president. Should both the president and vice president be absent or on the ballot, the Nominating Committee Chair will oversee the process.
3. Voting
  - All votes of the voting members shall be cast by electronic ballot, which shall be the sole method for determining votes unless the president, or in his/her absence the vice president, determines circumstances require a different method
  - Only registered delegates wearing the official badge and lanyard will be eligible to vote
  - Delegates must be in the delegate section in order to vote
  - If a majority vote is not reached on the first ballot, the candidate having the lowest vote total shall be dropped from the list. If more than one candidate, balloting continues with remaining candidates until each position is filled by a majority vote. If there is an equal number of candidates to positions available and one candidate does not receive a majority vote, that position is declared vacant.

## Nominations from the floor

In accordance with Article IV, Section B of the USBC Bylaws, nominees had to be submitted to the Nominating Committee, in writing, at least 30 days prior to opening of the Annual Meeting.

## Meet the Candidates

The Meet the Candidates session will be held Wednesday, May 1, from 10 a.m. – noon, in the Mardi Gras Ballroom. This is your opportunity to hear from the candidates running for the USBC Board of Directors.

# USBC NOMINATING COMMITTEE REPORT

**Purpose:** Prepares the slate of candidates for the USBC Board of Directors elections, voted by the USBC delegation, and provides recommendations to the International Bowling Campus (IBC) Youth Committee, which then submits the names for approval to the BPAA and USBC for their representation.

The committee is required to slate a minimum of three candidates and may slate up to six for the three open positions on the USBC Board of Directors. As a USBC Board candidate, minimum requirements must be met. Requirements include a signed disclosure form and candidates must have completed SafeSport Training and Registered Volunteer Program (RVP) requirements.

The committee evaluates candidates based on their professional resumes, education and knowledge, and bowling industry experience. Both the IBC Youth Committee and USBC Board of Directors look for skills such as leadership qualities, team player, problem-solving skills, communication, and, most importantly, those who would represent the best interest of the organization.

The Nominating Committee reviewed all submitted applications in November. Based on the experience and skillsets needed, the committee moved seven candidates ahead for face-to-face interviews. The interviews were conducted at the winter board meeting, which corresponds with the annual BPAA Summit, that was held in New Orleans.

Upon conclusion of the interviews, the committee voted to slate four candidates:

- Anthony Colangelo – Twin Falls, Idaho
- Rich Foran – Billings, Montana
- Bo Goergen – Sanford, Michigan
- Lowell Lovgren – Kelso, Washington

The biographies of the slated candidates are included in the convention program and posted on BOWL.com. A Meet the Candidates seminar will be held on Wednesday, May 1, prior to the USBC Annual Meeting. The candidates will be interviewed and attendees will have the opportunity to ask questions.

In accordance with Article IV, Section B of the USBC Bylaws, nominations from the floor for a USBC Board position had to be received by the Nominating Committee chair 30 days prior to the start of the Annual Meeting; that deadline is April 1, 2019. Candidates who met the deadline also could request to be included in the Meet the Candidates seminar.

The committee uses the same process for the IBC Youth Committee. The committee recommended three candidates. Moving forward, the IBC Youth chair will vote to reject or accept the committee's recommendations. The BPAA Board and USBC Board will vote on the final approval of the IBC Youth's Committee's decision.

# USBC EQUIPMENT SPECIFICATIONS AND CERTIFICATIONS COMMITTEE REPORT



**Purpose:** *Based on USBC strategic planning, this committee shall set direction to maintain and protect the integrity and credibility of the sport of bowling.*

To uphold this purpose, the Equipment Specifications and Certification (ESC) Committee remains guided by the USBC Vision “to continue to be the leading authority to the sport, servicing the needs of bowling.” The committee is responsible for reviewing and making final decisions regarding new items of equipment on which USBC approval is requested. The committee also is responsible for setting policies and procedures regarding equipment and specifications and for granting, withholding, suspending, withdrawing, or otherwise regulating bowling center certificates.

As the National Governing Body for the sport of bowling, USBC executes its mission to “provide services, resources and the standards for the sport.” Translating these bold statements into reality means engaging a world-class ESC Team at the International Bowling Campus, USBC’s home in Arlington, Texas. Our team of research engineers and research technicians invest significant resources in a continual effort to make sure your bowling experience is as fair as it is enjoyable and that bowling’s future is ensured through thoughtful research, planning, and delivery.

A substantial part of the groundwork performed by the ES group is behind the scenes. In 2018, USBC:

- Tested and approved **326 bowling ball models**
- Tested **31 additional bowling products** (cleaners, polishes, lane surfaces, ball plug, lane conditioners, lane decals, embedded warnings)
- Issued **27 bowling pin permits**
- Issued center certificates for the 2018-19 season currently standing at **3,973 centers comprising 87,000 lane beds.**

USBC has made significant progress in research and development of both existing and emerging specifications and technologies. Below are some brief highlights and notes detailing progress and changes across the past 12 months:

- Center Certification and Lane Inspection Program – Building on a successful start to major changes in both the lane inspection program and center certification process, USBC opted to continue data collection for another year. Additional detail on the data can be found in the December 2018 Center Certification Research Report located on BOWL.com. Certification for the 2019-2020 season will be granted to centers that submit all data and obtain the three signatures required by the new inspection form. This will allow USBC to further analyze and confirm accuracy of supplied data and refine and look for additional opportunities to improve the process. More than 960 people from 300 associations (in addition to 450 association volunteers at Convention) have attended Lane Inspection Workshops in the field. This commitment, coupled with the increased demands of the program, prompted USBC to also allow for a change to lane bed certification fees. Beginning in 2019-2020, a maximum of \$10 per lane bed may be charged, an increase from the \$5 implemented in 1995-1996
- Bowling Ball Specifications - Announced at Convention last year, key changes to bowling ball specifications underwent further analysis and modification. Exact details of those changes can be found on BOWL.com.
- The news release, published June 16, 2018, contains a concise explanation of the lengthened transition window regarding static weight specification changes being implemented Aug. 1, 2020. Further stakeholder conversations led the ESC to decide on a course that serves to balance the needs of governance and the practicality of field implementation. Additionally, “house balls” (definition in the article) also will be exempt from the gripping hole changes.
- Regarding oil absorption, bowling balls that will be grandfathered in on Aug. 1, 2020 that currently fall below the 2 minutes, 15 second oil absorption time limit must cease production no later than Jan. 31, 2022.

A sustainable future for the sport includes preserving a balance of time-honored tradition, foresight into what is sometimes unknown, a resolute focus on credibility, and responsibility to all stakeholders.

On a personal note, I would again like to offer a few words of gratitude – to Chad Murphy, Danny Speranza, the entire ESC staff and the ESC Committee. Thank you for your unwavering commitment to the complex work necessary to unravel the mysteries within the science of bowling. Your passion and knowledge make the many challenges seem less daunting and your love for our sport is inspiring. Also, to the USBC Board and President Karl Kielich, thank you for affording us the commitment and latitude to fulfill our committee charge with confidence.

The International Bowling Campus (IBC) Youth Committee is proud of the successes and progress of the past year. Together, we can get a few more kids to go bowling more often!

The IBC Youth Committee is made up of a diverse group of individuals who represent all of the youth bowling spectrum and have been working together to shape A Future for the Sport.

The **Mission** of the Youth Development Team is to “Cultivate opportunities to grow youth bowling through services, developmental programs and competitions.” Through this mission, we will deliver on a **Vision** of encouraging all children to experience the fun of organized bowling.

With the continued partnership of USBC and BPAA through the International Bowling Campus (IBC), they are providing us the opportunity with their continued financial support to keep youth bowling moving forward, growing and turning our youth bowlers into lifetime bowlers.

This year with a joint effort, IBC Youth has a new Strategic plan with a brand new look. We really wanted to focus on our core values:

To **SERVICE** bowling with **INTEGRITY** in all areas through **EDUCATION, TEAMWORK** and **COLLABORATION** with our partners. Above all, demonstrate and foster **LEADERSHIP** within the organization at all levels.

Let’s take a look at the products!

**Membership** – The cost of the memberships has remained unchanged. Collegiate and Junior Gold once again saw growth in membership and has record-breaking numbers. In order to target youth members at a younger age, more than 20,000 youth members 8 and under received a free Bowlopolis Upgrade kit.

**Junior Gold** – With a total number of 3,832 participants at the Junior Gold National Championships in Dallas, this event once again broke records. The program continues to look at new ways to evolve its brand and announced a new U17 division will be created for the 2018-2019 season.

**Youth Open** – The bowling.com Youth Open Championships had a successful launch of its new registration. The new system allowed consumers a more effective and efficient way to register the teams for the event. The event awarded over \$90,000 in scholarships.

**Pepsi Championships** – The Pepsi Youth Championships (Pepsi Tournament) is open to all USBC Youth members. This continues to be the largest youth scholarship in the country with more than 25,000 kids participating at the local level. Last season, the tournament awarded over \$600,000 in scholarships at the local and state levels.

**Bowler’s Ed** – The Bowler’s Ed program awarded a total of 46 grants to school districts and organizations around the country. There were over 4,300 curriculums handed out around the country to assist educators in teaching the program..

**High School/Middle School** – The department remains committed to being a resource for local and state initiatives seeking to create and grow high school bowling. The program moved the high school grant program online, which made it more visible to the public. As a result, there was an increase in the total amount of applications received, which allowed the program to issue all four \$2,500 grants.

**Collegiate** – Collegiate bowling continues to be one of the segments growing in the bowling industry. USBC Collegiate set records with 221 member schools and 3,825 student-athletes.

**USA Bowling** – The brand once again conducted 16 Regional Tournaments and the USA Bowling National Championships. Last season proved to be another successful season with the tournament setting record numbers in participants and teams.

The coaching program has been our flagship program and by developing more USA Bowling coaches, which, in turn, help make it possible for the league concept to flourish. We provide a minimum of 50 seminars each year, at no charge to those who apply.

# INTERNATIONAL BOWLING CAMPUS YOUTH COMMITTEE REPORT



A new USA Bowling Development Manager was hired to work with centers and associations who were interested in launching USA youth leagues in their local market. This re-launch of the program went into seven different local markets and resulted in 125 new bowlers.

# LEGAL AND LEGISLATIVE COMMITTEE REPORT



**Purpose:** *To ensure due process for our members, athletes and associations, as well as protecting the integrity of the sport. The committee also reviews proposed amendments and makes recommendations to the USBC Board.*

The committee handles two separate functions for the USBC Board. The legal side ensures due process for our members, athletes and associations, as well as protecting the integrity of the sport.

The committee has delegated authority, on behalf of the board, to make final decisions on appeals of staff decisions. Complete files of staff decisions are forwarded to the committee for its review and action. Committee members in a position of conflict recuse themselves from discussion and vote on said appeals. Any alteration, deletion or addition to the approved processes of this committee must go to the USBC Board for approval.

The committee also is responsible for conducting Hearing Panels to hear appeals for those decisions which involve suspension of membership, in accordance with United States Olympic Committee (USOC) guidelines.

The legislative component of this committee handles the proposed amendments. Recommendations are submitted to the USBC Board for each proposed amendment.

When a proposed amendment is announced to the delegation, there is no need for a second prior to discussion. If there is an amendment to a proposed amendment, that would require a second. It is recommended that any amendment to the published proposed amendments be submitted in writing to either the committee chair or a member of the Rules staff prior to the legislative session. When recognized by the chair, any delegate/member may speak for or against the issue on the floor. Each speaker is allowed two minutes, as well as a two-minute rebuttal.

A majority vote is required to adopt any proposed amendment to the Adult Tournament Rules and Adult League Rules. A two-thirds vote is required to adopt proposed amendments to the bylaws. Voting will be conducted by electronic voting device. Instructions will be provided prior to the legislative session.

**Purpose:** *To ensure the appropriate financial structure is in place to support the overall organization needs and strategic direction of USBC and its subsidiaries.*

We continue to review USBC's investment allocation to ensure compliance with policy guidelines. We emphasize, along with USBC's Finance Department, the continuing development of solid business processes with a focus on strong program planning and implementation.

The 2019 budget was presented to the Finance Committee and approved by the USBC Board of Directors in November 2018. The 2018 audited financials were completed by March 2019.

The Finance Committee recommended adoption of a Reserve Policy. The Reserve Policy was adopted at the November 2018 Board Meeting.
