# USBC YOUTH AMBASSADOR OF THE YEAR SCHOLARSHIP APPLICATION

**THE YOUTH AMBASSADOR OF THE YEAR AWARD** annually recognizes one male and one female USBC Youth bowler for his/her exemplary contributions to the sport of bowling, academic accomplishments and community involvement. Selection of winners is based solely on their contributions to the sport of bowling (excluding league or tournament play), academic accomplishments and community involvement. Any person or organization with knowledge of an individual's accomplishments in these areas may nominate that individual. Winners of this award must be current USBC Youth members.

Each of the award winners will receive a \$1,500 scholarship and an expense-paid trip to the awards ceremony held in conjunction with the USBC Convention. One of the two award winners may be selected as a member of the USBC Youth committee to serve on the committee for a period of three years.

In addition, the quality of the selected candidate's service on the Youth Committee could earn this person additional scholarship funds. Since it will be necessary for this person to travel independently to board functions, a Youth Ambassador selected to serve on the Youth Committee must be 18 years or older as of August 1 in the year of their selection.

The complete nomination form, nomination statement and any documentation must be submitted and received post-marked by **DECEMBER 1, 2016**, to be considered. The nomination will be held for consideration for two years, as long as the nominee is still age eligible to be a USBC Youth member.
