

OPEN AND WOMEN'S CHAMPIONSHIPS RESCHEDULING AND REFUNDS INFORMATION

The 2020 USBC Open Championships and 2020 USBC Women's Championships are suspended due to COVID-19 safety concerns. They're tentatively set to begin May 23, 2020.

Dates and times for teams scheduled from May 23 and forward do not change.

Below are directions and options for teams impacted by the starting date change.

Reschedule: For all teams registered for the Open Championships from March 21 through May 22, teams have the option to reschedule. You can:

HOTELS

MyBowlingVacation: Any hotels booked through MyBowlingVacation.com are reservations, with only some of them charging a one-day hold fee.
