**1.** Tournament will be certified by USBC and is a scratch event. **2.** All USBC rules will apply unless otherwise noted. **3.** Each bowler will bowl 5 games across 10 lanes. **4.** Each bowler must be a current 2021-2022 USBC member. **5.** Scholarships will be based on age and gender for the 2021-2022 bowling season. **6.** Prize ratio will be at least 1 in 6 or major fraction thereof. **7.** Walk-in entries will be accepted subject to lane availability. **8.** Tournament Director reserves the right to make an interpretation and decision on any rule, discrepancy and/or conflict that might arise. Decision of the tournament director shall be final unless appeal is made in accordance with Rule 329. **9.** Participants are limited to one entry into the Survivor Tournament. **10.** The Junior Gold Championships Qualifier will be based on age and gender for the 2022-2023 bowling season. **11.** Highest game will be used in the case of a tie for the final Junior Gold advancing spot. In the event of a tie, the next subsequent high game will be used to break the tie. **12.** The following bowling balls are prohibited for use. 900 Global Altered Reality, 900 Global Wolverine, Roto Grip UFO Alert, Storm Electrify Solid, Storm Phaze 4, Storm Trend 2.
