SURVIVOR TOURNAMENT RULES

1. Tournament will be certified by USBC and is a scratch event. 2. All USBC rules will apply unless otherwise noted. 3. Each bowler will bowl 5 games across 10 lanes. 4. Each bowler must be a current 2021-2022 USBC member. 5. Scholarships will be based on age and gender for the 2021-2022 bowling season. 6. Prize ratio will be at least 1 in 6 or major fraction thereof. 7. Walk-in entries will be accepted subject to lane availability. 8. Tournament Director reserves the right to make an interpretation and decision on any rule, discrepancy and/or conflict that might arise. Decision of the tournament director shall be final unless appeal is made in accordance with Rule 329. 9. Participants are limited to one entry into the Survivor Tournament. 10. The Junior Gold Championships Qualifier will be based on age and gender for the 2022-2023 bowling season. 11. Highest game will be used in the case of a tie for the final Junior Gold advancing spot. In the event of a tie, the next subsequent high game will be used to break the tie. 12. The following bowling balls are prohibited for use. 900 Global Altered Reality, 900 Global Wolverine, Roto Grip UFO Alert, Storm Electrify Solid, Storm Phaze 4, Storm Trend 2.
