## 2019 USBC OPEN CHAMPIONSHIPS 'ULTIMATE STRIKE PART 3' SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

The Sweepstakes: 2019 USBC OPEN CHAMPIONSHIPS 'ULTIMATE STRIKE PART 3' SWEEPSTAKES (the "Sweepstakes") provides a chance for a USBC member to win a Grand Prize which is (2) hotel room nights at the South Point Hotel and Casino, (1) customizable Logo Infusion jersey, (1) restaurant voucher to Don Vito's Italian Restaurant and (1) \$25 gaming credit voucher to South Point Hotel and Casino for the Grand Prize winner and his or her four teammates.

**Sponsor:** The Sweepstakes is sponsored by the United States Bowling Congress ("Sponsor"), 621 Six Flags Drive, Arlington, TX 76011 (the "Sweepstakes Address")

**Sweepstakes Period:** The Sweepstakes begins at 12:01a.m. Central Time ("CT") on July 24, 2018 and ends at 11:59p.m. CT on August 20, 2018 (the "Sweepstakes Period"). Sponsor's designated computer is the official time keeping device for this Sweepstakes.

**Eligibility:** The Sweepstakes is open to members of the United States Bowling Congress, 18 years of age or older, who are legal residents of one of the 50 United States or the District of Columbia. Age and membership status for purposes of the preceding sentence are determined as of the first announcement of this Sweepstakes (July 24, 2018). How to Enter: Any eligible entrant who registers for the Open Championships team event during the Sweepstakes Period and pays for his or her team entry during the Sweepstakes Period will be automatically entered into the Sweepstakes. Alternate Means of Entry. Eligible entrants may alternatively enter this Sweepstakes without making a purchase. Limit one entry per eligible entrant regardless of means of entry. Entries will not be acknowledged.

**Prizes:** After applicable verification and subject to compliance with these Official Rules, one (1) Grand Prize winner (the "Grand Prize Winner") will receive the following Grand Prize ("the Grand Prize"): (2) hotel room nights at the South Point Hotel and Casino for the Grand Prize Winner and (2) hotel nights for each of the winner's four teammates (those individuals participating on the Grand Prize Winner's team are referred to as "Guests" and the team

comprised of Grand Prize Winner and Guests is referred to as the "Grand Prize Team") (1) Logo Infusion customizable jersey, (1) Don Vito's Italian Restaurant dinner voucher and (1) \$25 gaming credit voucher valid at South Point Hotel and Casino for each member of the Grand Prize Team.
