

USBC "FRESH SQUAD" REFERRAL PROMOTION

- Terms and Conditions -

The Promotion: USBC is offering an opportunity for teams to earn free jerseys for their entire team by recruiting a minimum of two (2) "new" or "returning" players for the Open or Women's Championships.

Sponsor: The Promotion is sponsored by the United States Bowling Congress ("Sponsor"), 621 Six Flags Drive, Arlington, TX 76011 (the "Promotion Address").

Promotion Period: The Promotion begins at 8:00 a.m. Central Time on October 21, 2019 and ends at 11:59 p.m. Central time on December 31, 2019 (the "Promotion Period").

Eligibility: The promotion is open to all new teams that register for the "Fresh Squad" promotion using the online form available through BOWL.com during the Promotion Period. These teams must also separately submit entries for the USBC Open or USBC Women's Championships during the Promotion Period with rosters including a minimum of two (2) "new" or "returning" bowlers. To qualify as a "new" or "returning" bowler, a bowler may have not competed in the USBC Open or Women's Championships since 2016. This qualification applies to each tournament separately. Teams entering the promotion for the USBC Open Championships cannot have competed in the USBC Open Championships since 2016. Teams entering the promotion for the USBC Women's Championships cannot have competed in the USBC Women's Championships since 2016. A team's eligibility for one tournament is not affected by their past participation in the other tournament.

In order to allow for entry eligibility verification, all tournament entries must include their final rosters no later than thirty (30) days prior to their reserved Team competition date. Teams failing to submit their full team roster by this time may be deemed ineligible for the promotion.

Employees, agents, officers and directors of Sponsor, United States Bowling Congress and their respective affiliates, subsidiaries, advertising and promotional agencies ("Promotion Parties") and the immediate family members or household members of such persons are not eligible.

Participation in any part of the Promotion constitutes a participant's agreement to be bound by these Official Rules. Participants agree to be bound by the decisions of the Participation judges and such decisions shall be final. Sponsor reserves the right to permanently disqualify from this Promotion any person Sponsor believes has violated these Official Rules.

How to Enter: Entry into the Promotion requires both (1) registering for the promotion through the online form provided on BOWL.com and (2) separately entering a team or teams for the 2019 USBC Open or Women's Championship tournaments in accordance with the rules for those tournaments. Both entry requirements must be met prior to the end of the Promotion Period in order to be eligible for prizes.

All entries are dependent on eligibility verification. All Team entries for the USBC Open or Womens Championships must include final team rosters no less than thirty (30) days prior to the team's reserved Team competition date to allow for eligibility verification.

Prize: Eligible teams will receive a complimentary jersey for each member of their reserved Team. For teams at the USBC Open Championships, this will total five (5) jerseys. For teams at the USBC Women's Championships, this will total four (4) jerseys. Jerseys will be ordered based on the sizing each entrant provides when registering for the promotion. Requests for different sizes than what was ordered may be available but are dependent on inventory availability at the sole discretion of the Sponsor. Jerseys will be delivered to teams when they pick up their check-in materials at the tournament site.

Approximate retail value ("ARV") of the Prize is Eighty-eight Dollars (\$88) per jersey. Total ARV for teams at the USBC Open Championships is approximately Four-hundred forty Dollars (\$440). Total ARV for teams at the USBC Women's Championships is approximately Three-hundred fifty-two Dollars (\$352). Sponsor assumes no responsibility for unexpected fit of the jersey size requested, which all parties agree to be beyond its control. No transfer or substitution of prizes permitted except where required by law. If the Prize, or any portion of such prize, becomes unavailable, the Sponsor may award a substitute prize of equal or greater value. Taxes on the Prize are the sole responsibility of the Prize Winner, as the case may be. All expenses, costs and fees not expressly included above are the sole responsibility of Prize Winner, as the case may be. The total number of prizes to be awarded in the Promotion is dependent on the number of eligible teams that opt-in to participate. Sponsor reserves the right to request from any entrant to provide additional documentation it reasonably believes is necessary to validate any entry or to award any prize.

Sponsor may have need to try to communicate with potentially eligible entrants for various reasons related to the promotion, including but not limited to: questions to help confirm eligibility, jersey sizing, dates/times of competitions, on-site check-in, etc. It is the responsibility of the Entrant to ensure communication information provided to the Sponsor is accurate and up-to-date. Failure to meet any eligibility requirements or deadlines due to failure to receive communication from the Sponsor through information provided by the entrant may result in the entrant's disqualification from the promotion at the Sponsor's sole discretion.
