# **Providing Opportunities**

 Allow for more youth bowlers to experience the Junior Gold Championships which awarded \$250,000 in scholarships in 2013 in Detroit

 Allow more youth Bowlers to reap the benefits of the USBC Junior Gold membership program





**13-14 Membership Changes** 

U15 & U20 cost is \$30.00
\*\*New U12 cost is \$10.00\*\*

Birthdate of 8-1-2001 or later
Same benefits as U15 & U20

Must have a Youth STANDARD membership







# 13-14 Junior Gold Championship Tournament Changes

Adding a U12 Division
 – U12 Boys and U12 Girls

Boys will bowl in 3 centers Girls will bowl in 3 centers







# Junior Gold Championship Tournament Spot Costs

U20 spots are \$200.00
U15 spots are \$150.00
U12 spots are \$100.00







### **Junior Gold Championships Format**

- 3 days of qualifying (Monday -Wednesday)
  - 5 games each day for U15 & U20
  - 4 games each day for U12
  - Bowl in a different center each day
  - Each center will have a different lane pattern
- First cut is made Wednesday after 3 rounds
- 1:7 advance







### **Junior Gold Championships Format**

- Advancers to next round will bowl:
  - 5 additional games for U15 & U20
    - Cut to max of 64 to next round
  - 4 additional games for U12
    - U12 will cut to advancers for match play
- U15 & U20 will bowl 5 additional games
  - Cut to advancers for match play
- Finals are double elimination match play (Friday)







### **Enhanced Advancement Ratio Policy**

- How does the new advancer policy work for events using the "major fraction thereof" rule?
  - Once an event has met their minimum ratio and has entries in excess of that ratio, but short of the "major fraction thereof', they have the opportunity to advance one additional entrant to the NPJG Championships. The next advancer only, will be allowed to claim a spot by funding the balance of the monies needed to pay for that spot.

The "major fraction" spot is funded by the event.



### **Enhanced Advancement Ratio Policy**

- How does the new advancer policy work for events NOT using the "major fraction thereof" rule?
  - Once an event has met their minimum ratio and has entries in excess of that ratio, they have the opportunity to advance one additional entrant to the NPJG Championships. <u>The</u> <u>next advancer only</u>, will be allowed to claim a spot by funding the balance of the monies needed to pay for that spot. A detailed explanation of the policy can be found on the Junior Gold page of bowl.com.







H DEVELOPM

- 1:4 Ratio
- 7 Entries @ \$50 = \$350 in entry fees
- \$350 entry fee \$200 to NPJG = \$150 remain
- NOW, second place finisher can pay the additional \$50 to qualify and advance to the Junior Gold Championships



### **Premier Event – What is it?**

Provide a stipend (expense reimbursement)
Should be done as a reimbursement
Cannot exceed actual expenses for the player

- 4. Determine your qualifier format
- 5. Determine your entry fee
  - Take into consideration the anticipated entries

- 7. Determine your advancement ratio

- 2. Obtain League Certification Application
- 3. Complete and submit the application
- Determine if your league will be "Sport Bowling" certified www.bowl.com/sportbowling
- 5. Determine your league format
  - Must be scratch and at least 24 games





# **Top 10 things (Leagues)**

- 6. Determine your rules for the league
  - Start/end dates
  - Cost
  - How advancer is determined
- 7. Regular or Premier event
- 8. Advancement ratios options are:
  - 1:4, 1:10 or Champions only
- 9. Download Junior Gold Qualifying materials, applications and reports

10. At least ½ of the league participants MUST have a current Junior Gold membership

- Display your Tournament Certification Certificate
- Make sure you have your tournament rules on site
- Verify that all bowlers are current USBC Youth Members as well as USBC Junior Gold Members for 2013-14 season.
  - If needed have bowlers complete Junior Gold Membership Application and collect their Junior Gold membership fee.
    - Bowlers must be <u>USBC STANDARD</u> Youth Member to become Junior Gold member







### My Tournament is over....now what do I need to do?

- Within 15 days of completion of qualifier, complete Qualifying Post-Event Report and Finalist Report(s)

   Qualifying Post Event Report
   U12, U15 & U20 Finalist Report
- Submit completed forms and any payments to USBC
   E-mail, Fax, United States Postal Service, Pony Express, Carrier Pigeon (just get us the information <sup>(i)</sup>)
- Submit ALL scholarships monies to SMART within 30 days of completion of event

- Bowlers that advanced through qualifiers will receive an email verifying their information is correct
- Bowlers can go to <u>www.bowl.com/juniorgold</u> and look at the "Advancers Report" to see if their name appears





### **Important Qualifier Information**

- One month (30 days) prior to the event you must submit application and payment for the spot
- Within 15 days of the event concluding we must have your post event report and finalist report from event
- Within 30 days scholarship monies must be submitted to SMART
