Youth Membership Sweepstakes

OFFICIAL RULES

1. **ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR WIN.** Purchasing a product or service will not increase your chances of winning. Open to legal residents of the fifty (50) United States and the District of Columbia ("D.C.") who are thirteen (13) years of age or older (the "Entrant"). Employees, officers and directors of the IBC Youth Bowling Inc. ("Sponsor"), its affiliates, subsidiaries, promotion and advertising agencies, anyone involved with the design, execution or fulfillment of the Sweepstakes, and members of the immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate in this Sweepstakes. Non-eligibility or non-compliance with any of these Official Rules will result in disqualification.

The Youth Membership Sweepstakes (the "Sweepstakes") is subject to all applicable federal, state and local laws and regulations. The Sweepstakes is void outside the fifty (50) United States/D.C. and where prohibited by law.

2. **PROMOTION DATES/ENTRY PERIOD:** The Sweepstakes begins at 12:00 a.m. Central Time ("CT") on August 1, 2021 and ends at 11:59 p.m. CT on May 1, 2022 (the "Sweepstakes Period"). Sponsor's designated computer is the official time-keeping device for this Sweepstakes.

3. **HOW TO ENTER: If you are deemed a minor in your state of residence ("Minor"), then you must have the permission of your parent or legal guardian to enter the Sweepstakes.** Proof of such permission may be requested by Sponsor at any time and in any manner Sponsor deems reasonable.

(A) Visit www.bowl.com/youthgiveaway (the "Website") during the Sweepstakes Period and click on the link to access the official entry form (the "Entry Form") found [here](#). Complete the Entry Form in its entirety, including your first name, last name, telephone number (including area code) and email address, and answer the three simple questions to be entered into the "Sweepstakes"; OR

(B) To enter by mail, legibly hand-print your first name, last name, postal address, telephone number and email address (if you have one) on an approximately 3" x 5" card or piece of paper, and mail it in a standard, business-size envelope, with proper postage affixed to: International Bowling Campus Youth Development, Attention: Youth Membership Sweepstakes, 621 Six Flags Drive, Arlington, TX 76011.

Limit one (1) entry per person/email address for the entire Sweepstakes Period, regardless of the method used to enter. Any attempt by any Entrant to obtain more than one (1) entry by using multiple/different addresses, email addresses, telephone numbers, identities, and/or any other methods will void that Entrant's entries and that Entrant may be disqualified from the Sweepstakes, at the discretion of the Sponsor.

4. **SELECTION OF WINNER/ODDS:** One (1) winner (the "Prize Winner") of the prize described in Rule 6, below, will be chosen in a random drawing from among all eligible entries received in accordance with these Official Rules through both

If the Sweepstakes is terminated prior to the end date of the Sweepstakes Period, the prize will be awarded in a random drawing from among all eligible, non-suspect entries received through both entry methods combined prior to the time/date of termination. Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with or attempts to tamper with the entry process or the operation of the Sweepstakes, or who acts in violation of these Official Rules or in a disruptive manner. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that term.
