## Adult Membership Sweepstakes

## OFFICIAL RULES

1. ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR WIN. Purchasing a product or service will not increase your chances of winning. Open to legal residents of the fifty (50) United States and the District of Columbia ("D.C.") who are thirteen (13) years of age or older (the "Entrant").
